# **NCCC Competition Committee Minutes**

## **NCCC Convention Tulsa, OK. 6/21/08**

The Competition Mtg. was held from 4:00 to 6:00 P.M. All RCDs were present except for NE, WO, CA (Jack Wilson proxy), RR (Jim Gray proxy), & ER (Dave Walters proxy). There were 13 of 15 Regions represented.

There were no clarifications or specific convention issues needed to be discussed.

### **New Business:**

1. There were several incidences across the country that impacted several regional events from occurring or needing to be cancelled just before or the day of the events due to "natural disasters" i.e. tornadoes, severe storms, flooding. Since these events had to be cancelled within the 70 days, Section 1.3.11, Page 1-3, does not allow these events to be rescheduled. Jack suggested, since this year has been extremely unusual in its weather, he suggested the committee agree to allow these specific events be allowed for 2008 to reschedule these events.

The committee unanimously agreed to allow these specific events to be rescheduled if possible for 2008 and the committee will address language for the Govs to decide in November to cover "natural disaster" situations.

2. Jack asked the committee to discuss and decide what position we would like to recommend to the E-Board regarding providing written or CD documents to new and existing members in the future. Jack would take that input to the E-Board on Sunday morning as the E-Board is trying to finalize the 2009 Budget to be presented to the Govs in Sept.

Joan Thomas happened to be in attendance at this time and contributed some valuable insight into the process regarding what is on the Web and accessible.

The decision of the Competition Committee following discussion was to eliminate all written and CD distribution to new and existing members. The document on the Web is the official document as it is provided to Joan from Jack as the official document. Jack will provide Joan the document in Word format and Joan will transfer it to PDF for the Web. Anyone will be able to copy the specific Chapter of the Rulebook. They will not be able to edit or copy and paste information into the document. This will save NCCC significant expense in copying and mailings for the future while providing everyone with the current rulebook.

3. While Joan was there, there was a brief discussion as to the availability of the various forms in Sec. 12 which can be

electronically accessible. Currently the forms listed as part of this Section are not the electronic versions that can be used. It was decided the Comp. Committee will provide usable electronic versions of the various forms to Joan as part of Sec. 12 for the 2009 Rulebook so individuals won't have to go to two different parts of the Web for usable electronic forms.

Thank to Joan for her input into these topics.

4. The Committee then addressed number 7, 9, 10, 11, 12, 13, 14, 15, & 16 on the Rulebook Feedback Matrix. Refer to the attached for the comments and decisions on those items.

Committee Mtg. adjourned 6:00 P.M.

The Plan for addressing the balance of the items on the Rulebook Feedback Matrix will be as follows:

Weeks 7/4 thru 7/13: item nos. 17, 18 & 29 (part of Tire Committee), 19, 20, 21, 22, & 23.

**During this period, it is open for email discussion. At anytime you decide you have enough information on the topic, you can submit your vote as Yes, No, or Abstain. I will tally all votes on the morning of 7/14 and publish to you.**

Weeks 7/14 thru 7/27: item nos. 24, 25, 26, 27, 30, 31, 31, & 32.

Same process during this period, and I will tally all votes on the morning of 7/28 and publish to you.

Weeks 7/28 thru 8/10: item nos. 33, 34, 35, 36, 37, 38, 39, 40, & 41.

Same process during this period, and I will tally all votes on the morning of 8/11 and publish to you.

Note: At this point I will provide you with a summary of all 43 items listed plus any last minute issues we need to discuss over the next two weeks. At the end of that period, I will provide you with a document that will be given to the Govs at the September mtg. they can take with them to discuss with their regions for their November vote. If we have anything additional to add at the Sept. Committee Mtg. it will be verbalized to the Govs and provided to them email the following week.

All profits from the show are given to charities such as: Golisano Childrens Hospital, Aurora of NY, Arthritis Foundation, Leukemia & Lymphoma Society, Make-A-Wish, The Veterans Cemetery, The Syracuse Zoo, Ronald McDonald House, the American Lung Association and many others. The club won the prestigious Valvoline Eagle One award a few years ago. Typical family events include bowling parties, pancake breakfasts, picnics, club auctions, night cruises, weekend trips, rallies and road tours. They also have joint events with a few select clubs. In the past, the club has been involved in autocrossing. They meet twice a month and any Corvette owner 18 years or older can join or attend. ## **NATIONAL CLUB SPOTLIGHT: NCCC Youth Program Drives Toward Future**

The following article appeared in Hagerty's Car Club E-Newsletter recently.

Getting youth involved in the collector car hobby is a growing concern among car enthusiasts, but it's nothing new for the National Council of Corvette Clubs (NCCC).

The NCCC has been beating the drum for youth involvement for over 17 years, beginning with the creation of the Future Corvette Owners Association (FCOA) in 1991.

"Kids are the next generation of enthusiasts," said Pat Kelly, program director of the FCOA. "When you get them involved in the hobby, everybody wins."

That certainly was the feeling at the '91 NCCC National Convention, when introduction of the new youth program resulted in an initial membership of 76 kids. The club now boasts over 2,700, including many second-generation members. Over 3,900 youth have been in the FCOA at one time or another.

Members "age out" when they turn 16, and those FCOA graduates are then encouraged to join the NCCC. Three of the first four original members – Jennifer Dolan, Sarah Dolan and Catherine Parks – did exactly that, and Pat said they are still active in the hobby. Girls, by the way, are easy to find on the FCOA membership list.

"There are as many young girls joining the club as boys," said Pat, who has been FCOA Director since 1997 (following in the footsteps of past directors Marleen DeZeeuw and Karen Port.)

FCOA members take part in fun youth activities at shows and participate in contests that promote cars, in general, and Corvettes, in particular. In a 2003 contest called "My Dream Corvette," they drew, painted and wrote essays about the Corvette – real or imagined – that they dreamed of owning. The top six entries were awarded a trip to Corvette's 50<sup>th</sup> Anniversary Celebration in Nashville. FCOA members have also had an opportunity to win trips to Bloomington Gold or snag a pedal car.

For a one-time fee of \$5 – which hasn't changed since 1991, thanks to sponsorship of businesses like Mid America Motorworks – club members receive a membership car, patch, newsletter and other specialty items. Prospective FCOA members must be related to a member of the NCCC in order to join.

NCCC Sponsorship Director, Debbie Lindsey, said she isn't surprised that kids are interested in the FCOA. She is taken aback, however, by just how large the club has grown. Debbie's sons, Colin and Brent Lindsey, signed up the very first day back in 1991. They were member Nos. 31 and 32.

Debbie said Pat deserves much of the credit for the huge growth in membership.

"I never dreamed that it would get this big," Debbie said. "But Pat has taken it to a different level. She has a lot of energy, and it takes those bursts of people getting involved to push it forward."

Look no farther than Florida for proof of that. Glenn Hutchinson, the Florida region's new executive (president), and Patsy Shearer, its membership director, have joined forces to increase their FCOA membership by more than 100 members since last year.

"They've got kids excited about Corvettes, and that's the whole purchase of the club," Pat said. "If you get them excited and keep them learning, they want to own their own Corvette some day – and they'll carry on the hobby."

Led by the Midwest Region, the FCOA currently has members in 48 states and Washington, D.C., as well as Canada, the United Kingdom, Germany, Japan, Guam and Trinidad. There are also members at APO and FPO (military) addresses.

Inquiries about the Future Corvette Owners Association have increased so much over the years that the club now has its own website – [www.corvettesnccc.org/fcoa1](http://www.corvettesnccc.org/fcoa1) — and email address — [FCOAKids@aol.com](mailto:FCOAKids@aol.com).

The FCOA's push toward youth involvement is already being felt by the NCCC.

"Other clubs' average age is 55 to 60," Pat said. "Ours is 42 and a half."

That perfectly illustrates Pat's point that everyone wins by getting youth involved in the collector car hobby.

"I'm actually surprised that more clubs don't do it," she said. "It takes time, effort and money, but it's worth it."

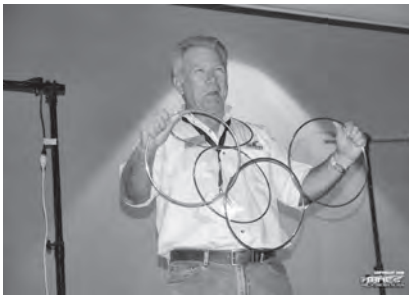

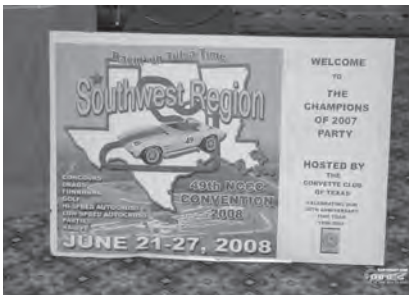

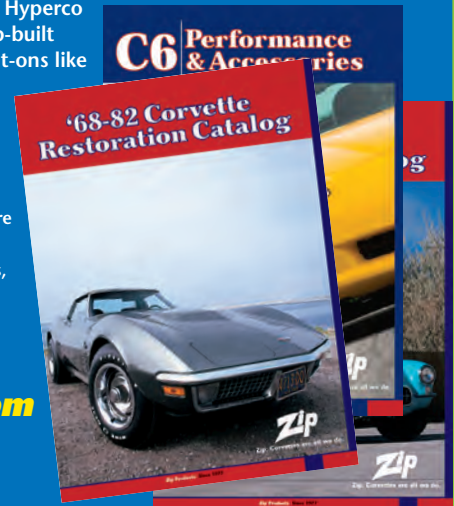
